COMPETITION RULES #VINCIAirportsSpottersDay Challenge

ARTICLE 1: ORGANISER

VINCI Airports, hereinafter the "Organiser", a société par actions simplifiée (simplified limited liability company) incorporated in France with capital of €389 096 514, the registered office of which is at 12/14, rue Louis Blériot - CS 30071, 92506 Rueil-Malmaison Cedex and which is registered under the number 410 002 075, is organising a competition between 15/11/2019 and 19/11/2019, at midnight (Paris time) with no purchase being necessary on the terms set out in these rules.

The photos of the competition entitled "#VINCIAirportsSpottersDay Challenge" are taken during the VINCI Airports Spotters Day event held on 16 November 2019 (15 November for Clermont-Ferrand Auvergne, 17 November for Rennes Bretagne and 18 November for Siem Reap).

ARTICLE 2: PARTICIPATION

The Competition is open to adults and minors with parental permission, who have an Instagram account.

Accordingly, no registration made by telephone, fax or e-mail other than on the Instagram account of VINCI Airports will be taken into account.

Participation in the Competition is free and participants are not required to make any purchases.

The persons involved directly or indirectly in the preparation of the Competition, are excluded, as are members of their family and their partner (of the same name and with the same address). If the player is a minor, he or she must have the written permission of his or her parents and/or legal guardian, which must be produced immediately at the Organiser's request. The Organiser reserves the right to ask for this permission and to disqualify any Participant if it is not produced.

Interaction with any content implies unqualified acceptance of these Competition rules.

Participation in this Competition implies express and unqualified acceptance of these rules, of the ethical rules in force on the internet (code of conduct, etc.), and on Instagram, and of the laws and regulations in force in French, Portuguese and Cambodian territories, and in particular of the provisions applicable to competitions in force in France, Portugal and Cambodia. Consequently, failure to comply with these rules, and in particular with the required conditions of participation, or breach of the other provisions referred to above, will result in the player being disqualified.

Every player undertakes not to do anything illegal or contrary to public morals, to comply with the laws and regulations in force, to respect the rights of third parties and to observe the provisions of these rules.

ARTICLE 3: TERMS AND CONDITIONS OF REGISTRATION AND PARTICIPATION

Instagram is a third party not involved in the organisation of this operation. Every participant expressly acknowledges that the Competition is not managed or sponsored by Instagram. Every participant therefore expressly acknowledges that in no circumstances may Instagram be held responsible for any dispute associated with this Competition. Any questions, observations or complaints concerning the Competition should be addressed to the Organiser of the Competition and not to Instagram.

In order to play, it is necessary to have an Instagram account and to follow the VINCI Airports' Instragram account (https://www.instagram.com/vinciairports/?hl=fr).

On the occasion of the VINCI Airports Spotters Day organised on 16 November 2019 (15 November for Clermont-Ferrand Auvergne and Toulon Hyères, 17 November for Rennes Bretagne and 18 November for Siem Reap), spotters will be invited to take pictures of the airport infrastructure and of the planes with their smartphone, device or camera and to post it on Instagram with the hashtag #VINCIAirportsSpottersDay as well as the tag of the VINCI Airports' Instagram account @vinciairports, in a public post.

The Competition begins on 15 November 2019 and will end at midnight on 19 November 2019 (Paris time). Two winners will be chosen at the end of the competition, the first by a jury of VINCI Airports' experts and the second by the public. The public prize will be awarded to the spotter who has received the most "Like" mentions on Instagram at the end of the competition.

Photos must be taken at the airport on the day of the VINCI Airports Spotters Day event, on the day of the event.

Participants agree not to use or post an image that contains:

- Addresses, phone numbers, URL addresses, account or personal identification numbers
- Sexual, violent or other offensive content (including nudity)
- Profanity or obscenities
- Illegal or anti-social behaviour
- Culturally, insensitive images
- Images which display the opinions of socially unacceptable groups
- Anything else illegal, obscene, libellous, defamatory or indecent.

Pictures showing a risk situation for the contestant or any other person will be excluded from the competition.

ARTICLE 4: PRIZES

The prizes to be won are as follows:

2 cameras awarded to each of the 2 winners. Unit value of 1000€ maximum.

This prize cannot be exchanged in whole or in part for its cash value. It cannot be deferred or amended and is not transferable.

No disputes or claims of any kind will be entered into with regard to prizes.

The winners undertake not to seek to hold the Organiser liable with regard to the prizes, in particular as regards their quality, or in respect of any consequences arising from possession of a prize.

The Organiser cannot be held liable if the stay has to be postponed or cancelled for reasons of force majeure or any other cause outside its control. It cannot be held liable for any incidents/accidents that might occur when using prizes.

Any alteration on the part of the winner taking place after the reservation will be charged for.

ARTICLE 5: TERMS AND CONDITIONS OF AWARD OF PRIZES

Information provided to winners and prize validation:

The winners will be informed of their win by private message if possible, or via a publication posted directly on the Instagram account of VINCI Airports.

A post placed on the page will announce the winner and will show his or her entry, his or her first name and the first letter of his or her family name. That person will be asked to communicate his or her identity (family name, first name, address, e-mail address, age and proof of identity) in a private message to be sent to the Instagram account of VINCI Airports where his or her portrait was displayed.

The purpose of gathering this information is to organise the receipt of the winners' prizes. If a reply providing the personal contact details of the winner(s) is not received by the Organiser within a period of 21 calendar days (family name, first name, postal address, email address), the prize(s) will not be distributed to a another person.

Unused prizes or prizes that are refused by the winner as offered will not be reallocated and will remain the property of the Organiser. The winner will then lose the benefit of the prize without the Organiser incurring any liability.

In the absence of confirmation by the winner as stated above, he or she will be regarded as having disclaimed his or her prize.

The winner must abide by the rules. Should it appear that the winner does not satisfy the criteria contained in these rules, his or her prize will not be awarded and will remain the property of the Organiser.

In order to benefit from his or her prize, the winner must be able to produce documentary proof of identity and address matching his or her entry form, at the Organiser's request. Any false declaration or false statement of identity or address will result in the participant's immediate elimination and if applicable the return of any prizes already sent.

Participants authorise the Organiser, in advance and as the case may be, to publish their name, first name and photograph on any advertising medium or in the context of any

promotional operation relating to this prize draw, without such publication resulting in any right to payment or remuneration of any kind whatever.

If a winner objects to the use of his or her contact details (other than his or her first name and the first letter of his or her family name), he or she must give notice of that objection without delay to VINCI Airports via: communication@vinci-airports.com

The Organiser is not under any obligation to respond to participants' requests (whether made in writing, by e-mail, by fax or on the telephone) regarding the way the Competition is organised, the interpretation or application of these rules or the list of winners, even after the Competition closes.

Article 6: LIMITATION OF LIABILITY

The Organiser has no power to moderate the content shared by users in the context of the Competition, except after it is posted. It cannot therefore be held responsible for such content.

Participation in the Competition implies knowledge and acceptance of the characteristics and limitations of the internet, particularly as regards technical performance, response times for consulting, querying or transferring information, the risks of interruption, and more generally, the risks inherent in any internet connection and transmission, the absence of protection for certain data against potential misuse and the risks of infection by any viruses circulating on the network. Consequently, and without prejudice to the generality, the Organiser cannot in any circumstances be held liable:

- 1. for the transmission and/or receipt of any data and/or information on the internet;
- 2. for any dysfunction of the internet network preventing the Competition from running or functioning correctly:
- 3. for the breakdown of any receiving equipment or lines of communication;
- 4. for the loss of any paper or electronic mail and, more generally, for the loss of any data:
- 5. for delivery problems;
- 6. for the functioning of any software;
- 7. for the consequences of any virus, computer bug, error or technical defect;
- 8. for any damage caused to a Participant's computer;
- 9. for any technical, physical and software defect of any nature that prevents or limits the ability to participate in the Competition or that damages a Participant's system;
- 10. For the malfunction of the prizes distributed in the context of the Competition, and for any direct and/or indirect damage that they might cause.

For the avoidance of doubt, the Organiser cannot be held responsible for any direct or indirect damage resulting from an interruption or dysfunction of any kind or for any reason, or for any direct damage resulting in any way from a connection to the site developed in the context of this Competition. Every Participant will be responsible for taking the necessary steps to protect the data and/or software on his or her computer against any damage. Connections by any person to the social media platforms referred to above and the participation of Participants in the Competition take place entirely at their own risk.

The Organiser may cancel all or part of the Competition if it appears that there has been fraud of any kind particularly using computers or in the determination of the winners. In that event, the Organiser reserves the right not to award the prizes to the persons responsible for the fraud and/or to take action in the competent courts against such persons. However,

the Organiser cannot be held liable in any way to the Participants by reason of any fraud that might be committed. In particular, the use by a Participant of one or more fictitious names or of names borrowed from one or more third persons shall be regarded as fraud, and every Participant must take part in the Competition using his or her own unique name. Any fraud will result in the elimination of the Participant concerned.

The Organiser reserves the right, for any reason whatever, to cancel, postpone, interrupt or extend the Competition or to amend all or part of the terms of these rules, in compliance therewith. If, as a result of events outside its control, the Organiser is obliged to use this right, it cannot be held liable on that account.

The Organiser reserves the right to permanently exclude any person from the various Competitions in the event that, by his or her fraudulent conduct, he or she undermines the successful running of the Competition. Similarly, any attempt to use the Competition outside the unmodified interface put in place on the site will be regarded as an attempted fraud. In addition, decompiling the Competition, using personal script or any other method aimed at circumventing the intended use of the Competition as provided by these rules will also be regarded as an attempted fraud and will result in the immediate elimination of the player concerned, without right of appeal.

ARTICLE 7: DATA PROCESSING AND CIVIL LIBERTIES

The personal information gathered in the context of this Competition will be processed in accordance with the French Data Protection Law no. 78-17 of 6 January 1978, as amended and General Data Protection Regulation (GDPR).

a) Authorization to use the photos - Exclusive transfer of copyright.

The participant undertakes to transfer his photographs free of charge to VINCI Airports without any financial compensation or of any other kind. No pictures will be returned to the participant. The use of the pictures will allow VINCI Airports to promote and enhance the

territory. The participant guarantees that he/she owns the copyright to the photographs sent, agrees to be identified as such and authorizes VINCI Airports to reproduce them free of charge. The transfer of copyright by the photographer induces in particular the right of reproduction, representation and adaptation for promotional purposes. VINCI Airports can therefore use the photos on all media and in all formats: magazines, posters, leaflets, objects, internet, press insertion, social networks, etc. VINCI Airports will be able to use the photos for public representation purposes. If necessary, the company will be able to modify the framing, add a text to the photograph, sound the presentation, present it in internal and external corporate presentations.

ARTICLE 9: COPY OF THESE RULES

ARTICLE 10: EVENTS OF FORCE MAJEURE - RIGHT TO EXTEND THE COMPETITION

The Organiser cannot be held liable if, due to an event of force majeure or that is outside its control, the Competition has to be altered, shortened or cancelled.

The Organiser reserves the right in any event to extend the period of participation and to postpone any announcement date.

Any amendment of the rules will be filed with the acting firm of Court Bailiffs and will enter into force on the date on which it is published online, and any participant will be deemed to have accepted it by virtue of his or her participation in the Competition, with effect from the date of entry into force of the amendment.

Any participant refusing the amendment or amendments must cease to participate in the Competition.

ARTICLE 11: APPLICABLE LAW AND JURISDICTION

These rules are subject to French law. Any difficulty relating to the application, interpretation or effects of these rules will be resolved by the Organiser.

ARTICLE 12: INTERPRETATION OF THESE RULES

Entry to the Competition implies complete and unconditional acceptance of the terms and conditions set out in these rules. During the period of the Competition, the Organiser will not respond to any question concerning the practicalities of its organisation.

The Organiser will settle any question relating to the application of these rules, or any question that is asked that is not covered by these rules. Its decisions will not be subject to any appeal.

Any dispute or complaint relating to this Competition must be made in writing and sent to the Competition address and will only be taken into consideration within a period of one month from the closing date of the Competition.
